Mr. Schundler indicated that BeLoved's proposal indicated that the Board of Ed's Pre-K Program which was using four classrooms on the first floor of the CERC could continue to do so. He also indicated that BeLoved utilized the SABA program of study and noted they are getting outstanding results. Mr. Schundler stated that BeLoved purchased the building they are in presently and also built an addition; however, there is a real need downtown with expansive real estate development and indicated that the CERC is perfect.
