The Chairman called the Meeting to order at 6:04 p.m., and upon roll call the following answered present:

Immediately following the Pledge of Allegiance the Assistant Executive Director announced that in accordance with the "Open Public Meetings Act," a copy of the Public Notice was sent to the Jersey Journal and to the City Clerk for the public's review and information.

The Chairman acknowledged any public speakers and Irina Shalaeva who requested the Board consider having the community involved in the development of the Morris Canal Redevelopment Area. The Chairman told Ms. Shalaeva that they met at the meeting with regard to the 23 Cornelison Avenue presentation. The Chairman indicated that he would set up a meeting among himself, the developer and the community so that the developer can present their proposal to the community.


