

MINUTES OF THE REGULAR MEETING OF THE BOARD OF COMMISSIONERS OF THE JERSEY CITY REDEVELOPMENT AGENCY HELD ON THE 21st DAY OF MARCH, 2017

*

The Board of Commissioners of the Jersey City Redevelopment Agency met in a Regular Meeting at the Agency office, 30 Montgomery Street, Jersey City, New Jersey on Tuesday, March 21st at 6:00 p.m., the place and date duly established for the holding of such Meeting. The Chairman called the Meeting to order at 6:02 p.m., and upon roll call the following answered present:

and the following were absent: NONE. The Chairman thereupon declared a quorum present. Also present at the Meeting were Christopher Fiore, Assistant Executive Director; Diana H. Jeffrey, Esq., General Counsel; Barbara Amato, Secretary to the Board and secretary the Meeting; Ben Delisle, Director of Development; Sarah Goldfarb, Director of Policy and Research; LaBron Collins and Rob Napiorski, Project Assistants, Jennifer Credidio, Esq. and Joseph Baumann, Esq., Special Counsels to the Agency and those listed on the attached Attendance Sheet.

Immediately following the Pledge of Allegiance the Assistant Executive Director announced that in accordance with the "Open Public Meetings Act," a copy of the Public Notice was sent to the Jersey Journal and to the City Clerk for the public's review and information.

The Chairman indicated there was a presentation and Mr. Clay McPhale addressed the Board with regard to 41-52 Aetna Street. Mr. McPhale indicated that his firm, Argent Ventures was designated for various lots in the area so this project will comprise the entire area. There is a three acre city park which will be reconfigured and a series of buildings that will vary in height. Mr McPhale noted they are proposing altering the lot line of Monitor Street. First of the buildings will be 370 units in 6-8 stories.

The Chairman then acknowledged the public speakers. Mr. Henry Gage addressed the Board with his community's concern regarding SciTech Scity. He indicated the major issue is the lack of collaboration with the community. Mr. Gage indicated there is a need for additional input from the community and the people want to work together with the City. The Chairman informed Mr. Gage that this is only the "first step" in a long process. As we go through that process, there will be public hearings as well. The Chairman also noted that all redevelopers are encouraged to seek out community input and partner with them. Mr. Gage's retort was that promises weren't kept; there were a series of tax abatements; claims the Mayor made regarding 51% participation by minority and women's businesses. The Chairman then told Mr. Gage that he would be more than willing to provide more insight into the process.

At this time the Board agreed to go into closed Session. Accordingly, the following Resolution was introduced and duly seconded:
