





The Board of Commissioners of the Jersey City Redevelopment Agency met for their Regular Board Meeting located at, 180 Ninth Street, Jersey City, New Jersey on Tuesday, October 16, 2018 at 6:00 p.m., the place and date duly established for the holding of such Meeting.
